- 1. The Friends of Vallajeelt School 100 Club will operate as a society lottery in accordance with the Gambling, Betting and Lotteries Act 1988, registration number F10376/2025.

- 3. The Club will be run by the Friends of Vallajeelt School (Isle of Man Registered Charity 586) who will appoint one or more Administrators.

- 5. For the cost of £1 per draw you will be allocated a unique membership number.
- 6. A draw will be made on the first Monday of every month between, and including, October to July.
- 7. Where school is not open on the first Monday of the month, the draw will take place on the next available school day.
- 8. Each draw will be made at school in the presence of at least three people including one Trustee of the Friends of Vallajeelt School.
- 9. The prizes will total 50% of the total income for that month. This will be apportioned as: First prize 25%, second prize 15% and third prize 10%.
- 10. The 100 Club is a private lottery and is open to all parents, carers, staff and friends of Scoill Vallajeelt. Anyone aged 16 or over can join.
- 11. There are no limits on the number of members of the Friends of Vallajeelt School 100 Club or on how many entries each member can have.
- 12. Payments must be made in advance of a draw to be included and member's numbers will only be entered if their subscription is up to date.
- 13. The winning members will be contacted within one week of the draw to the transfer of winnings.
- 14. The winning numbers for each draw will be posted on the charity website and also on the charity Facebook page.
- 15. In the case of any dispute, the decision of the Trustees of the Friends of Vallajeelt School is final.
- 16. After the 10th and final draw of the school year (July), members will be extended an invitation to renew their subscription for next set of 10 draws due to commence in October of the next school year.
- 17. Applications to join the 100 Club received part way through the school year will be assessed to determine the amount of subscription due based on how many draws remain in the school year, where tickets cost £1.
